Subject: Unauthorized absence of doctor – joining thereof.

Government Order No. 290 -JK(HME) of 2023

WHEREAS, Dr. Peerzada Mohd Shafi was initially appointed as Medical Officer vide Government Order No. 335-HME of 2010 dated 17.06.2010 and later on appointed as Consultant Medicine vide Government Order No. 698-HME of 2015 dated 20.10.2015 and posted at SDH Kralpora, Kupwara;


AND WHEREAS, Dr. Peerzada Mohd Shafi, Consultant Medicine, while posted at SDH Kralpora applied for study leave for undergoing DNB in Neurology at Apollo Hospital Bangalore;

AND WHEREAS, vide letter No. Est/II/1995 dated 29.07.2020, Chief Medical Officer Kupwara, intimated that as per report of the Block Medical Officer Kralpora, the doctor had left to join DNB course w.e.f 21.10.2019 without prior permission from the Competent Authority;

AND WHEREAS, vide letter No. Est/3/1-133/858 dated 03.03.2023, Director, Health Services, Kashmir has intimated that Dr. Peerzada Mohd Shafi, Consultant Medicine has approached in the Directorate on 20.10.2022 with an application stating therein that he has completed DNB course of 03 years and requested for acceptance of his joining in the Department;

AND WHEREAS, the matter has been examined in the department and it has been observed that the doctor was eligible for study leave at that time as per the rules governing the subject, but he left for pursuing DNB in Neurology at Apollo Hospital Bangalore on 21.10.2019 without seeking prior approval from the competent authority;

AND WHEREAS, the doctor has completed his DNB in Neurology and shown his willingness to serve the patients, therefore, the Department has taken a lenient view and decided to accept the joining report of Dr. Peerzada Mohd Shafi, Consultant Medicine.



NOW, THEREFORE, sanction is hereby accorded:-

- a. to accept the joining report of Dr. Peerzada Mohd Shafi, Consultant Medicine notionally w.e.f. 20.10.2022 and monetarily with immediate effect, subject to following conditions:-
 - i. He was not involved in any subversive activities as well as was not employed in any other Government/private sector during the said period, for which an affidavit duly authenticated by the 1st Class Judicial Magistrate be obtained by the Directorate of Health Services, Kashmir.
 - ii. The concerned doctor is warned not to leave his place of posting for any occasion whatsoever in future, without proper permission from the competent authority, failing which, disciplinary action in terms of Jammu & Kashmir Civil Services Regulations Volume-I shall be initiated against him without any further notice.
- b. that the intervening period of absence in favour of Dr. Peerzada Mohd Shafi, Consultant Medicine shall be decided separately by the Departmental Designated Committee.
