**WHEREAS,** on the recommendations of J&K Public Service Commission conveyed vide letter No. SC/Dr/Lect/Radio-Diagnosis/H&ME/2022 dated 23.12.2022, **Dr. Omair Ashraf** S/O Mohd Ashraf R/O 167 Balgarden, Karan Nagar, Srinagar was appointed as Lecturer in the Department of Radio Diagnosis under OM Category in State Cancer Institute at Super Specialty Hospital, Government Medical College, Jammu, vide Government Order No. 97-JK(HME) of 2023 dated 01.02.2023;

**AND WHEREAS,** the aforementioned Government Order, among other conditions, provided that the candidate shall join within a period of 21 days, failing which the appointment shall be deemed to have been cancelled *ab-initio* without any further notice;

**AND WHEREAS,** Principal, Government Medical College, Jammu has reported that the above candidate has failed to join within stipulated time of twenty one (21) days and has requested for necessary action in the matter;

**AND WHEREAS,** the case has been examined in the Department and it has been decided to cancel the appointment of Dr. Omair Ashraf as Lecturer, Radio Diagnosis in State Cancer Institute, Government Medical College, Jammu for failing to join within a period of twenty one (21) days.

**NOW, THEREFORE,** the appointment of Dr. Omair Ashraf S/O Mohd Ashraf R/O 167 Balgarden, Karan Nagar, Srinagar, as Lecturer (Radio Diagnosis) in State Cancer Institute at Super Specialty Hospital, Government Medical College, Jammu is hereby cancelled *ab-initio*.
