The inter-se-seniority of the appointee(s) shall be determined in accordance with the merit of the J&K Public Service Commission.

The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.

The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
