Subject: Settlement of intervening period of absence in favour of Dr. Tahira Akhter, Medical Officer, on deputation to Government Medical College, Anantnag.

Government Order No. 1016 – JK (HME) of 2023

AND WHEREAS, Director, Health Services, Kashmir vide Communication No. Est/3/1-133/8315 dated 04.12.2021 has stated that Dr. Tahira Akhter was appointed as Medical Officer vide Government Order No.132-HME of 2014 dated 04.03.2014 and submitted her joining report in Directorate of Health Services, Kashmir on 08.03.2014;

AND WHEREAS, during the period, the aforesaid doctor was undergoing P.G Diploma in Gynae at Government Medical College, Srinagar, therefore, the doctor was initially kept on inter-cadre deputation vide Government Order No. 302-HME of 2014 dated 13.06.2014 and later on, vide Government Order No. 635-HME of 2014 dated 21.10.2014 permission was granted to all the Medical Officers, who were appointed vide Government Order No.132-HME of 2014 to continue their P.G Degree/Diploma Course subject to the condition that the intervening period of undergoing P.G course shall be decided separately;

AND WHEREAS, the doctor, after completion of P.G Diploma, joined back in the Directorate of Health Services, Kashmir on 01.08.2015 and subsequently, Director, Health Services, Kashmir posted her at CHC Zainpora vide order No. 194-GZ of 2015 dated 08.08.2015;

AND WHEREAS, in pursuant to the order No. 194-GZ of 2015 dated 08.08.2015, the doctor did not join at her place of posting at CHC Zainpora instead requested for posting to District Kulgam;

AND WHEREAS, Director, Health Services, Kashmir posted the aforesaid doctor at DH Kulgam vide Order No. 524-GZ of 2015 dated 28.10.2015 and later on, sanctioned the period w.e.f. 08.08.2015 to 28.10.2015 as 'Leave without pay' vide order No. Est-3/1-133/1923-24 dated 27.08.2016;

AND WHEREAS, Chief Medical Officer, Kulgam, vide letter No. CMOK/Est-I/MO/3063 dated 06.09.2021, forwarded the application of the doctor concerned to the Director, Health Services, Kashmir for settlement of her intervening period of undergoing P.G. Diploma w.e.f. 08.03.2014 to 31.07.2015;

AND WHEREAS, the matter was placed before the Departmental Designated Committee in its meeting held on 03.08.2023 under the chairmanship of Director Finance, Health & Medical Education Department, who deliberated upon the matter and recommended as under:-

"(a) To treat the period of unauthorized absence of the doctor spent on higher studies at GMC Srinagar w.e.f. 08.03.2014 to 31.07.2015 as "Dies-non" which shall be subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Govt/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor.

Besides, the doctor shall be warned not to leave her place of posting on unauthorized basis in future for which departmental actions shall be initiated against her without any notice".

NOW, THEREFORE, on the recommendation of the Departmental Designated Committee, sanction is hereby accorded to treat the period of unauthorized absence of Dr. Tahira Akhter, Medical Officer spent on higher studies at GMC Srinagar w.e.f. 08.03.2014 to 31.07.2015 as "**Dies-Non**", subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Govt/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor.

Besides, the doctor shall be warned not to leave her place of posting on unauthorized basis in future for which departmental actions shall be initiated against her without any notice.
