In pursuance to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Services (Leave) Rules, 1979 read with SRO-346 of 2012 dated 17.10.2012 & SRO-274 of 2013 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Mr. Gharu Ram, MTS, Government Medical College, Srinagar (presently working in Health & Medical Education Department) for undergoing O.T. Technician Course at BMS College, Gangyal, Jammu, for a period of one year (out of two years) w.e.f 1<sup>st</sup> December, 2023 in the first instance, subject to the following conditions that:-

- i. the work load on account of his study leave shall be managed through internal arrangement;
- ii. the official shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. the stipend, scholarship etc., if any, received during pursuing of higher studies is adjusted in his leave salary;
- iv. all other relevant conditions as laid down in Study Leave Rules are strictly adhered to.
- v. On the completion of course, the applicant shall submit the certificate of examination passed or special courses of study undertaken, indicated the date of commencement and termination of the course to the Principal GMC, Srinagar.
- vi. A period entry of Study leave is made in the Service Book of the official.
