WHEREAS, Dr. Vabita Bhagat was appointed as Medical Officer vide Government Order No.335-HME of 2010 dated 17.06.2010;


AND WHEREAS, at the time of appointment, the aforesaid doctor was pursuing MS Ophthalmology in Government Medical College, Jammu, therefore, she continued the same and after completion of said course, she submitted her joining report in the Directorate of Health Services, Jammu on 04.06.2012;

AND WHEREAS, the doctor concerned was selected for the tenure post of Registrarship in the Department of Ophthalmology at Government Medical College, Kathua and vide letter No. HD-Gaz/Gen07/2019 dated 25.01.2019, among others, she was allowed to join the Registrar-ship subject to the condition that the period spent on said course shall be decided separately in consultation with concerned HODs after completion;

AND WHEREAS, after completion of said course and relieving from GMC Kathua vide No. GMCK/Admn/2021-22/6471-78 dated 24.01.2022, the doctor concerned submitted her joining report in the Directorate of Health Services, Jammu on 24.01.2022;

AND WHEREAS, vide letter No. ES-3/5709/987 dated 02.06.2023, Director, Health Services, Jammu has submitted the case of Dr. Vabita Bhagat, Medical Officer for settlement of period of undergoing Registrarship from GMC Kathua w.e.f. 25.01.2019 to 24.01.2022 in her favour;

AND WHEREAS, the case of aforesaid doctor was placed before the Departmental Designated Committee in its meeting held on 03.08.2023 under the chairmanship of Director Finance, H&ME. The Committee recommended as under:-

"(a) To treat the period of absence of Dr. Vabita Bhagat for undergoing registrarship in Govt Medical College, Jammu w.e.f. 25.01.2019 to 24.01.2022 as leave whatever kind is due to her except study leave and remaining period as 'Dies non' which shall be subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Govt/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the doctor shall be warned not to leave her place of posting on unauthorized basis in future for which departmental actions shall be initiated against her without any notice".

NOW, THEREFORE, on the recommendation of the Departmental Designated Committee, sanction is hereby accorded to treat the period of undergoing Registrarship at GMC Kathua w.e.f. 25.01.2019 to 24.01.2022 in favour of Dr. Vabita Bhagat, Medical Officer "as leave whatever kind due, except study leave and remaining period as 'Dies non', subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Govt/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.
