Sanction is hereby, accorded to the:

1. Release/Re-validation of Rs. 3774.09049 lakhs (Rupees Thirty Seven Crore Seventy Four Lakh Nine Thousand Forty Nine) only, unspent balance of 2022-23 under Centrally Sponsored Scheme, "Up-gradation of existing State Government/ Central Government Medical Colleges to increase MBBS Seats in the country", in favour of Director Finance, Health & Medical Education Department for its further placement at the disposal of Principal, Govt. Medical College Srinagar/Jammu for utilization during the current financial year (2023-24) as per the following details:

2. Advance drawl of Rs. 3774.09049 lakhs (Rupees Thirty Seven Crore Seventy Four Lakh Nine Thousand Forty Nine) only as detailed above, by Director Finance, Health & Medical Education Department for crediting the funds into the Single Nodal Agency (SNA) Account of the Scheme so that funds be e-transferred to Principal, Govt. Medical College, Srinagar/Jammu for its utilization on the approved components of scheme during the current financial year 2023-24.

The sanction for release/revalidation and advance drawl of funds shall be, however, subject to the following conditions:-

1. The expenditure shall be made strictly according to the classification under which funds have been authorized by the Finance Department.
2. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
3. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
4. Treasury Officers shall not allow parking or drawl of funds in the Civil Deposit without the prior concurrence of the Finance Department.
5. The Principal Govt. Medical College, Srinagar/ Jammu shall send status report about the scheme in terms of physical and financial progress made during the current financial year.
6. The Principal Govt. Medical College, Srinagar/ Jammu shall send the Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2024 to Govt. of India under intimation to this department.



7. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.
8. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BEAMS portal and accordingly release/transfer the funds to the concerned.
9. The Principal Govt. Medical College, Srinagar/ Jammu shall incur expenditure strictly as per the guideline of the scheme and the conditions laid down in the sanction letter of the concerned ministry of Government of India.
10. All conditions as contained in BEAMS generated release order be adhered to in letter & spirit.
11. Red Accounts of the Advance drawl be submitted to the concerned quarters well in time.
12. The funds shall be debited as per the following account classification:


