Subject: Release/ Advance Drawl of UT Share for Centrally Sponsored Scheme "Pradhan Mantri- Ayushman Bharat Health Infrastructure Mission (PM-ABHIM)" under Capex Budget 2023-24.

Sanction is hereby accorded to the release and advance drawl of Rs. 245.00 lakhs (Rupees Two *Crore Forty Five lakhs*) only, under Capex Budget 2023-24 as matching UT Share under Centrally Sponsored Scheme "Pradhan Mantri - Ayushman Bharat Health Infrastructure Mission (PM-ABHIM)" in favour of Mission Director, National Health Mission, J&K for its utilization during the current financial year (2023-24) towards the approved components of the scheme enabling the receipt next installment of funds from the Ministry of Health & Family Welfare, Govt. of India.

The release/ advance drawl of funds shall be subject to the following conditions:

1. Mission Director, National Health Mission, J&K shall furnish the physical and financial progress report every month to this Department, which shall be open to on the spot verification.
2. The expenditure shall be booked on admissible items only as approved by the competent authority.
3. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
4. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
5. Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
6. The funds so released shall be utilized for the specific purpose meant for without any deviation.
7. All the required codal formalities as per GFR-2017 shall be followed at all levels with due diligence while incurring expenditure out of the funds already authorized.
8. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BAEAMS portal and accordingly release the same to the concerned HOD.
9. The UCs/ Red Accounts of the advance drawl shall be furnished to the concerned quarters within the stipulated time.


