Subject: Termination of probation of Dr. Vishal Kant, Lecturer (Anaesthesiology) in Government Medical College, Srinagar.

WHEREAS, on the recommendations of J&K Public Service Commission, vide Government Order No. 275-JK(HME) of 2023 dated 03.04.2023, Dr. Vishal Kant S/O Brij Lal R/O 262 Near Dr. In Khosla Clinic Dharmal Lower Muthi Jammu was appointed as Lecturer in the discipline of Anesthesiology in Government Medical College, Srinagar, under SC Category, subject to the fulfillment of all other usual terms and conditions of appointment;

AND WHEREAS, on 09.12.2023, Dr. Vishal Kant submitted his resignation before Principal, Government Medical College, Srinagar citing reason of his appointment as Assistant Professor (Anaesthesiology) in Government Medical College, Udhampur, in terms of Government Order No. 996-JK(HME) of 2023 dated 05.12.2023;

AND WHEREAS, Principal, Government Medical College, Srinagar forwarded the application of the said faculty member duly endorsed by HoD Anaesthesiology, Government Medical College, Srinagar for acceptance of his resignation;

AND WHEREAS, Rule 21(1) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956 provides as under:

"At any time before the expiry of the prescribed period of probation, the appointing authority may:

- (a) Suspend the probation of a probationer and discharge him from the services for want of vacancy; and**
(b) at its discretion terminate the probation of a probationer and discharge him from the service".

AND WHEREAS, the matter has been examined in the Health & Medical Education Department in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956 and it has been decided to terminate the probation of Dr. Vishal Kant and discharge him from services of Government Medical College, Srinagar w.e.f. 09.12.2023 (A.N);

Now, therefore, in exercise of the powers conferred under Rule 21(1)(b) of J&K Civil Services (Classification, Control and Appeal) Rules, 1956, the probation of Dr. Vishal Kant S/O Brij Lal R/O 262 Near Village Nalla Mallian P.O Ghordi Tehsil Ramnagar appointed as Lecturer (Anaesthesiology) in Government Medical College, Srinagar vide Government Order No. 275-JK(HME) of 2023 dated 03.04.2023, is hereby terminated and he is discharged from services of Government Medical College, Srinagar w.e.f. 09.12.2023 (A.N), on his own request.
