Subject: Settlement of intervening period of absence in favour of Dr. Shveta Mahajan, Dental Surgeon, PHC Lakhanpur.

WHEREAS, Director, Health Services, Jammu vide letter No. DHSJ/ES-3/5282/4715 dated 25.10.2022 & No. ES-3/5282/6035 dated 03.02.2023 has intimated that Dr. Shveta Mahajan was appointed as Dental Surgeon vide Government Order No. 496-HME of 2005 dated 29.08.2005 and submitted her joining report in Directorate of Health Services, Jammu on 30.08.2005;

AND WHEREAS, the doctor after being relieved from Indira Gandhi Government Dental College, Jammu had reported in Directorate of Health Services, Jammu on 06.01.2010;

AND WHEREAS, the doctor had submitted an application, alongwith selection letter, stating therein that she had been selected for undergoing MDS course at Teerthankar Mahaveer Dental College & Research Centre, Moradabad and, accordingly, had requested for permission along with deputation under Article 44-F;

AND WHEREAS, Director, Health Services, Jammu vide letter No. ES-3/5282/852 dated 30.06.2010, forwarded the request of doctor to the Administrative Department, but the doctor concerned had left without NOC/permission from the Administrative Department;

AND WHEREAS, Director, Health Services, Jammu, has also stated that the said doctor had reported in the Directorate of Health Services, Jammu on 21.07.2018 in

response to the Administrative Department Notice issued under endorsement No. HME/HRM/179/2017 dated 09.07.2018;

AND WHEREAS, the doctor was posted at PHC Lakhanpur in pursuance to Administrative Department approval conveyed vide letter No.HD/Gaz/Gen/TF-10/2015-1 dated 13.09.2019;

AND WHEREAS, the case regarding settlement of intervening period of absence w.e.f. 15.07.2010 to 20.07.2018 in favour of Dr. Shveta Mahajan, Dental Surgeon was placed before the Departmental Designated Committee in its meeting held on 02.02.2023 under the chairmanship of Director Finance, Health & Medical Education Department, which examined the case meticulously and recommended as under:

"to treat the period w.e.f. 15.07.2010 to 24.11.2014 (Higher Study period) & 25.11.2014 to 20.07.2018 (unauthorized absence) as 'Dies-Non' and also subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Government/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor shall be warned not to leave her place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against her without any further notice".

NOW, THEREFORE, on the recommendation of the Departmental Designated Committee, sanction is, hereby, accorded to treat the intervening period of absence w.e.f.
