## Government Order No: 202 - JK(HME) of 2024 Dated: 14 -03- 2024

In pursuance of Rule 61(1), Rule 62(a) & Rule 73(1) of J&K Civil Services (Leave) Rules, 1979 read with SRO 346 dated 17.10.2012 & SRO-274 dated hereby, accorded in favour of Dr. Bilal Shafiq Dar, Medical Officer, SDH Kokernag, Anantnag for undergoing Post MBBS Diploma in Radiology at Government Medical College, Anantnag for a period of one year (out of two years) w.e.f. 03.11.2023 subject to the following conditions that:-

- i. The work load on account of his study leave shall be managed through internal ii.
- That the doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- The course undertaken is purely in public interest and shall prove beneficial to the iii. Department:
- The doctor shall submit the certificate of examination of 1st year passed before the iv. Administrative Department prior to seeking extension in study leave;
- the stipend, scholarship etc., if any, received by the doctor during study leave is V. adjusted in his salary and;
- The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu vi. and Kashmir Civil Service (Leave) Rules, 1979.
- In case, the doctor abandons his higher study course midway, the delinquent doctor vii. shall be subject to the imposition of following penalties:
  - i. Withholding of two increment.
  - Imposition of a penalty amounting to the tune of Rs. 2.0 lacs alongwith the ii. recovery the total amount paid to the delinquent doctor during the training of said course.
  - Ban from future participation in Government-sponsored educational programs or training courses for a period of 5 years.
