- 5. The UCs/ Red accounts of advance drawl shall be furnished to the concerned quarters within the stipulated time.
- 6. Director Ayush, J&K shall furnish the physical and financial progress report of the scheme every month to this Department, which shall be open to, on spot verification.
- 7. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
- 8. Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
- 9. The funds shall not be parked un-necessarily.
- 10. All conditions contained in BEAMS release order shall be adhered to.
