**Subject:- Release and advance drawl of funds under Centrally Sponsored Scheme "National AYUSH Mission" during the year 2023-24.**

In continuation to Govt. order No. 1058-JK (HME) of 2024 dated. 18/12/2024, sanction is hereby accorded to the:-

1. Release of Rs. 1685.53 lakhs (Rupees Sixteen Crore Eighty Five Lakhs Fifty Three Thousands) only, as grant-in-aid released by the Ministry of AYUSH, Govt. of India under Centrally Sponsored Scheme "National AYUSH Mission (NAM)" and its placement at the disposal of Director Ayush, J&K, Jammu. 2. Advance drawl of Rs. 1685.53 lakhs (Rupees Sixteen Crore Eighty Five Lakhs Fifty Three Thousands) only as detailed above, by Director Ayush, J&K for e-transfer of funds into the Single Nodal Account (SNA) of NAM Scheme (J&K AYUSH Society) for utilization of funds during the current financial year 2023-24.

The release of funds shall be subject to the following conditions:-

- a. The expenditure shall be made strictly according to the classification under which funds have been authorized by the Finance Department.
- b. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
- c. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
- d. Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
- e. The Director, Ayush, J&K shall send status report about the scheme in terms of physical and financial progress made during the current financial year.
- f. The Director, Ayush, J&K shall send Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2024 to Govt. of India in the prescribed format under intimation to this department.
- g. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.

- h. Director Finance, Health & Medical Education Department shall vouchsare the availability of funds on BEAMS portal and accordingly release the funds to the concerned.
- i. The expenditure shall be incurred strictly as per the guidelines of the scheme and the conditions laid down in the sanction letter of the concerned Ministry of Government of India.
- j. The funds shall not be available for re-appropriation/ diversion at any level.
- k. All conditions as contained in BEAMS Generated order be adhered in letter & spirit.
- l. The Directorate of Ayush, J&K shall submit a proposal for release of balance amount of Rs. 192.06 lakhs at the commencement of the FY 2024-25.
- m. Director Ayush must ensure judicious use of these funds strictly as per government guidelines rules, GFR 2017.**
- n. The funds shall be debited as per the following account classification:


