- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department:
- The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department prior to seeking extension in study leave:
- That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in her salary and;
- vi. The doctor shall execute a bond in Form-6, in terms of the Rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.
- In case the said doctor abandons her study leave midway, she shall vii. be subject to the following penalties:
  - a. witholding of two increments.
  - b. Imposition of penalty to the tune of Rs. 2.0 lacs alongwith recovery of total amount paid during the training of said course.
  - Ban from future participation in Government-sponsored educational programs or training courses for a period of 5 years.
