Government Order No. 266 -JK(HME) of 2024 Dated: 01 -04- 2024

In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Halima Parveen, Medical Officer, PHC Verinag, Anantnag for undergoing Post MBBS Diploma (Obstetrics and Gynaecology) at Government Medical College, Baramulla for a period of one year (out of two years) with immediate effect, subject to the following conditions:-

- i. The work load on account of her study leave is managed through internal arrangement;
- ii. That the doctor shall have no superior claim over her seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in her salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.
- vi. In case, the doctor abandons her higher study course midway, she shall be subject to the imposition of following penalties:
 - a. Withholding of two increments.
 - **b.** Imposition of a penalty amounting to the tune of Rs. 2.0 lacs alongwith the recovery the total amount paid to the delinquent doctor during the training of said course.
 - **c.** Ban from future participation in Government-sponsored educational programs or training courses for a period of 5 years.
