Subject: Application of Dr. Saleem Ahmad Lone (Medical Officer), SDH -Gurez for settlement of absence period.

Government Order No.268 -JK(HME) of 2024
Dated: 03 -04-2024

Whereas, Dr. Salem Ahmad Lone, was appointed as Medical Officer vide Government order No.132-HME of 2014 dated 04.03.2014 and was posted at SDH Kreeri vide Government order No.302-HME of 2014 dated 13.06.2014;

Whereas, the doctor was transferred to SDH Gurez vide Government order No.417-HME of 2014 dated 11.07.2014, where he did not join;

Whereas, a notice was issued to doctor by the DHSK vide his office letter No.Est-3/1-133/7217-19 dated 27.10.2014, wherein, an opportunity was given to doctor to resume his duties at SDH Gurez within (07) days ;

Whereas, the doctor failed to join and the case was submitted to Administrative Department vide letter No. Est-3/1-133/7585 dated 24.11.2014 for termination of probation of the doctor;

Whereas, Administrative Department vide letter No.HME/HRM/179/2017 dated 17.09.2018, issued final notice to the doctor for un-authorized absence and directed him to join back, pursuance to which the doctor joined in Directorate Health Services, Kashmir on 26.09.2018 and was posted at SDH Gurez vide order No.Est/3/1-133/4846-48 dated 27.09.2018;

Whereas, the case of Dr. Saleem Ahmad Lone, Medical Officer, SDH Gurez was examined in the Department and was placed before the Departmental Designated Committee in its meeting held on 15.06.2023, which recommended as under:-

"To treat the period w.e.f. 11.07.2014 to 25.09.2018 in favor of the Dr. Saleem Ahmad Lone, Medical Officer SDH Gurez as "Dies Non" and shall be subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any government/private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by 1st class

Judicial Magistrate shall be obtained by the DHSK from the concerned doctor.

Besides, the concerned doctor shall be warned not to leave his place of posting at any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice".

Now, therefore, on the recommendation of the Committee and after approval of the Competent Authority, sanction is hereby accorded to treat the period w.e.f. 11.07.2014 to 25.09.2018 in favour of Dr. Saleem Ahmad Lone Medical Officer SDH Gurez as "Dies Non" and shall be subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any government/private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the DHSK from the concerned doctor. Besides, the concerned doctor shall be warned not to leave his place of posting at any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.


