Subject: Complaint against Shri Ghulam Mohammad Tantray, Section Officer and Shri Iqbal Ahmad Trambo, Head Assistant, Directorate of Family Welfare, MCH and Immunization, J&K (Veri No. SLK-29/2014).

Government Order No. 290-JK(HME) of 2024

Whereas, State Vigilance Organization (Now Anti Corruption Bureau), J&K vide their letter No. VO-Veri-SLK-29/2014-13332-34 dated 31.08.2018 recommended, Regular Departmental Action against the following officials of Directorate of Family Welfare, MCH & Immunization, J&K:

- i. Shri Ghulam Mohammad Tantray, Section Officer; and
- ii. Shri Iqbal Ahmad Trambo, Head Assistant;

Whereas, the General Administration Department vide OM. No. GAD(Vig)76-Comp/2018 dated 26.09.2018, advised the Health and Medical Education Department to initiate Regular Departmental Action against the delinquent public servants in light of the recommendations of Vigilance Organization in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956;

Whereas, the case was examined in the department and vide this department's letter No.HME/HRM/194/2018 dated 25.01.2019, Director Family Welfare, MCH & Immunization J&K was asked to serve Articles of charges, statement of Imputations to the delinquent officials, besides, to submit the replies of the same to this Department along with his comments/recommendations;

Whereas, Director Family Welfare, MCH & Immunization, J&K vide letter No.DFW/JK/Est/ ths.Sup/JLNM/PF/06/ 217/20376 dated 05.03.2019, intimated that a Committee was constituted vide Order No.DFW/JK/Est/ths.Sup/JLNM/PF/06/217/ 17998-18001 dated 01.02.2019 to enquire into the matter and get the factual position about the alleged involvement of the delinquent officials;



Whereas, the report submitted by the committee reveals that there is no guilt on the part of concerned officials and also an undertaking to this effect has been given by the complainant Sh. Syed Faheem Bukhari that he has not paid any graft;

Whereas, the department accepted the recommendations of the Director Family Welfare, MCH & Immunization, J&K as well as Enquiry Committee and vide Government Order No. 72-JK(HME) of 2019 dated 23.12.2019, complaint filed by Mr. Syed Faheem Bukhari against Mr. Ghulam Mohammad Tantray, Section Officer and Mr. Iqbal Ahmad Trambo, Head Assistant of Directorate of Family Welfare, MCH & Immunization, J&K was closed as the allegations were not proved;


Whereas, vide O.M. No. GAD(Vig)76-Comp/2018 dated 24.11.2020, General Administration Department observed that the instant case requires to be re-looked by the Health & Medical Education Department and advised for de-novo enquiry through a senior officer and furnish the Action Taken Report in the matter;

Whereas, vide Government Order No. 915-JK (HME) of 2020 dated 23.12.2020, a Committee comprising of following officers was constituted to enquire into the charges framed against the accused officials afresh:-

1. Mr. Madan Lal, Chief Accounts Officer, Directorate of Family Welfare, MCH and Immunization, J&K; and
2. Mr. Anoop Luthra, Deputy Director (Planning), Directorate of Family Welfare, MCH and Immunization, J&K;

Whereas, vide letter No. DFW/JK/2020-21/9845 dated 30.01.2021 and letter dated 11.10.2021, the enquiry Committee submitted its report, stating therein, that the complaint filed by Sh. Syed Faheem Bukhari, Theatre Supervisor, JLNH Hospital, Srinagar before Vigilance Department J&K is baseless and concerned officials may be acquitted from the charges leveled against them, besides, recommending for closure of case;

Whereas, the enquiry report has been examined in light of the allegations leveled against the said officials and it is observed that as per the recorded conversation between Complainant and the official of Directorate of Family Welfare, MCH & Immunization, J&K, the complainant was pressed to pay Rs. 60,000 to 70,000/- for DPC clearance and for getting promotion benefits released, but the complainant did not pay the same;



Whereas, the case was examined in the department taking into consideration all the aspects of the case and it was observed that these officials have acted in a manner which is un-becoming of a public servant. Hence, it was decided to impose penalty against these public servants in terms of Rule 30 of the J&K Civil Services (Classification, Control & Appeal) Rules 1956;

Now, therefore, after approval of the Competent Authority, sanction is hereby accorded to impose the penalty in favour of the following officials of Directorate of Family Welfare, MCH & Immunization, J&K so that they shall remain careful in future while discharging their duties:-

- i) Penalty provided under Rule 30(ii) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956 i.e. **"fine equivalent to one month's pay"** is imposed in favour of Sh. Iqbal Ahmad Trambo, Head Assistant.
- ii) Penalty provided under Rule 30(i) of the J&K Civil Services (CCA) Rules, 1956 i.e. **"Censure"** is imposed in favour of Sh. Gh. Mohammad Tantray, Section Officer.


