In terms of Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Rahid Rasool Malla, Medical Officer, NTPHC Fagow for undergoing Fellowship in Government Medical College, Srinagar for a period of one year from the date of commencement of course,

However, this shall be subject to the following conditions:-

- i. The work load on account of his study leave is managed through internal arrangement;
- ii. The doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. The stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the Rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.
- vi. In case the said doctor abandons his study leave midway, he shall be subject to the following penalties:-
  - a. withholding of two increments.
  - b. Imposition of penalty to the tune of Rs. 2.0 lacs alongwith recovery of total amount paid during the training of said course.
