Subject: - Deputation of Dr. Reyaz Ahmad Khan, Medical Officer, for undergoing tenure posting (Microbiology) at GMC Srinagar.

Sanction is hereby accorded to the deputation of Dr. Reyaz Ahmad Khan, Medical Officer to Government Medical College, Srinagar for undergoing tenure posting/training course as Senior Resident in the Department of Microbiology for a period of three years with immediate effect on the standard terms and conditions of deputation.

However, this shall be subject to the following conditions:-

- i. He has completed period of probation or 3 years of service whichever is later and is intending to undergo such tenure posting/training course for first time during his service.
- ii. He shall retain his lien/promotion prospects in his own parent department.
- iii. He shall have no superior claim over his seniors for consideration of promotion after acquiring such higher qualification(s).
- iv. In case, the concerned doctor fails to rejoin back in his parent department immediately after completion of such tenure posting/training course, disciplinary proceedings shall be initiated against him without any further notice.
- v. In case the said doctor abandons his course midway, he shall be subject to the following penalties:-
 - a. withholding of two increments.
 - b. Imposition of penalty to the tune of Rs. 2.0 lacs alongwith recovery of total amount paid to the delinquent doctor during the training of said course.
 - c. Ban from future participation in Government-sponsored educational programs or training courses for a period of 5 years.



