- 1. The above candidates shall report to Principal, Government Dental College, Srinagar. In case of failure of the appointee to join within a period of twenty one (21) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
- 2. The appointee shall be allowed to join only on production of following documents/certificates in original:
  - a. Date of Birth Certificate.
  - b. Qualification Certificates.
  - c. Domicile Certificate.
  - d. Health Certificate from the Standing Medical Board.
  - e. Any other documents as required under rule.
- **3.** The appointment of the above candidate as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory reports in this regard are received in his favour.
- **4.** The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2022.
- 5. The appointee shall be on probation for a period of two years.
- **6.** The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
