In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Services (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Andleeb Fazal Qurashi, Consultant Anesthesia, MCCH GMC Anantnag for undergoing Post Diploma DNB (Anesthesiology) at Government Medical College, Anantnag for a period of one year (out of two years) with immediate effect in the first instance.

However, this shall be subject to the following conditions that:-

- i. the work load on account of her study leave shall be managed through internal arrangement;
- ii. the doctor shall have no superior claim over her seniors for consideration for promotion after acquiring higher qualification;
- iii. the course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. the doctor shall submit the certificate of examination of 1st year passed before the Administrative Department prior to seeking extension in study leave;
- v. the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in her salary and;
- vi. the doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.

Besides, Director, Health Services, Kashmir shall ensure that Clinical work do not suffer under any circumstances at the place of posting of the doctor i.e. MCCH, GMC, Anantnag.


