Sanction is, hereby, accorded to the deputation of Dr. Pawan Kumar Sharma, Medical Officer (MD Community Medicine), PHC Totte Block Reasi to Government Medical College, Jammu for tenure posting/training course as Demonstrator in the department of Community Medicine (PSM), for a period of three (03) years on standard terms and conditions of deputation subject to the following conditions:-

- i. He has completed period of probation or 3 years of service, whichever is later, and is intending to undergo such tenure posting/training course for first time during his service.
- ii. He shall retain his lien/promotion prospects in his own parent department.
- iii. He shall have no superior claim over his seniors for consideration of promotion after completing the tenure posting.
- iv. In case the concerned doctor fails to rejoin back in his parent department immediately after completion of such tenure posting/training course, disciplinary proceedings as warranted under rules shall be initiated against him without any further notice.
