- 5. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BEAMS portal and accordingly release the funds to the concerned.
- 6. The instructions/ conditions as contemplated in the BEAMS order shall be adhered/ fulfilled in letter & spirit.
- 7. Expenditure shall be booked as per the following classification:-
