Ex-post facto sanction is hereby accorded to the reimbursement of the medical expenses incurred by Dr. Neelam Rani, Demonstrator on the treatment of her husband at Max Super Specialty Hospital, Saket, New Delhi in relaxation of rule 6-A of the J&K Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, subject to the following conditions:-

- a. Reimbursement of charges shall be restricted to items / procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items / procedures at AIIMS, New Delhi.
- b. All relevant medical bills / vouchers shall be got verified from relevant Medical Authority of the hospital wherefrom treatment has been taken.
- c. Essentiality Certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- d. Certificate from Competent Medical Authority (Director Health Services / Principal GMC / Other) is obtained to establish the genuineness of the treatment availed in the said hospital.

This issues with the concurrence of Finance Department conveyed vide U. O No. FD-Code/135/2021-03-1109 dated 01-11-2021 and approval of the competent authority conveyed by General Administration Department vide U.O No. GAD-CORD/243/2021 dated 10-05-2023.


