3. The leave applied by the officer is sanctioned by the competent authority before embarking on the travel;
4. An entry shall be made in the service book of the officer as prescribed under Rule 16 (1) and 16 (2) of the J&K Civil Services (LTC) Rules, 2019;
5. The final LTC claim on the form 3 shall be submitted to the head of the office within three months from the date of return journey;
6. The entitlement is regulated by the concerned DDO under rules;
7. The dependence of family members of the officer is established under rules;
8. The journey is undertaken by the shortest possible route.


