Subject: Settlement of authorized/unauthorized absence period in favour of Dr. Firdous Ahmad Bangroo, Medical Officer, Laper Hospital Srinagar.

WHEREAS, Dr. Firdous Ahmad Bangroo was appointed as Medical Officer vide Government Order No. 592-HME of 2011 dated 28.10.2011 and reported before Deputy Commissioner/ CEO LAHDC/ Kargil on 14.11.2011;

AND WHEREAS, during the said period, the doctor was undergoing P.G in Orthopedics at Government Medical College, Jammu and after completion of the same, he joined in the Directorate of Health Services, Kashmir on 08.06.2013;

AND WHEREAS, while posted at CHC Sankoo, the doctor concerned proceeded on five (05) days casual leave w.e.f. 27.12.2013 and after availing the said leave, he failed to report back;

AND WHEREAS, the doctor after completion of Senior Residency from SHKM, GMC, Mewat Haryana submitted his joining report on 18.01.2017 in the Directorate of Health Services, Kashmir;

AND WHEREAS, vide letter No. Est/3/1-133/6227-28 dated 27.03.2017, Director, Health Services, Kashmir submitted the case of the doctor concerned to the Administrative Department for further instructions, however, pending instructions from Administrative Department, Director, Health Services, Kashmir posted the said doctor at DH Qazigund;



AND WHEREAS, Director, Health Services, Kashmir vide communication No. Est-3/1-133/1522 dated 12.04.2023 forwarded the case of Dr. Firdous Ahmad Bangroo, Medical Officer for settlement of his period of undergoing higher studies w.e.f 01.01.2014 to 31.03.2017 to the Administrative Department for issuance of appropriate necessary instructions;

AND WHEREAS, the case was placed before the Departmental Designated Committee in its meeting held on 15.06.2023. The Committee examined the case and recommended as under:

"To treat the period w.e.f. 01.01.2014 to 31.03.2017 in favour of the said doctor as "Dies Non" and shall be subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any government/private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the DHSK from the concerned doctor.

Besides, the concerned doctor shall be warned not to leave his place of posting at any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice".

NOW, THEREFORE, on the recommendation of the Departmental Designated Committee, sanction is hereby accorded to treat the period **w.e.f. 01.01.2014 to 31.03.2017** in favour of Dr. Firdous Ahmad Bangroo, Medical Officer as "**Dies Non**", subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any government/private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by 1st class



Judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor.

Besides, the concerned doctor is warned not to leave his place of posting at any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.
