In terms of Article 230, Clause (i) of the Jammu and Kashmir Civil Service Regulations Volume-I read with SRO-217 dated 22.05.2017, issued by the Finance Department, post-facto sanction is hereby accorded to the voluntary retirement of Mtr. Hasina Bano, Ex-FMPHW, Block Tral, District Pulwama of Directorate of Family Welfare, MCH & Immunization, J&K, w.e.f. 01.01.2023, subject to the following conditions:-

1. That there is no departmental/judicial enquiry pending against the official.
2. That the official is having permanent status/five years of quasi permanent in status or is confirmed on any post.
3. That service is verified with reference to Pay A.C. Roll w.e.f. 09.04.1993 to 01.01.2023.
4. That sanction to voluntary retirement from competent authority is invariably furnished with the pension case.
5. That the Head of the office shall ensure that the fixation of pay recorded in the service book has been verified by him/her in accordance with Finance Department's Circular No. A/60 (78) -194 dated 14.02.2005. Rule 17.4 of J&K Financial Code Vol (I) may also be referred to.
