Subject:- Engagement orders of faculty positions of Government Unani Medical College Ganderbal under S.O 364 of 2020.



WHEREAS, vide Government order No 211-JK(HME) of 2023 dated 10.03.2023 12 candidates were engaged as Assistant professors in various disciplines, in Government Unani Medical College cum Hospital Ganderbal, Kashmir, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, notified vide S.O 364 dated 27.11.2020.

AND WHEREAS, the selected candidates were directed to report, principal, Government Unani Medical College cum Hospital Ganderbal Kashmir, for joining within a period of 21 (twenty one) days from the date of issuance of the engagement order, failing which his/her engagement shall stand cancelled ab-intio, without any further notice;

AND WHEREAS, one candidate namely Dr Shabir Ahmad Bhat S/O Farooq Ahmad Bhat was selected against the post of Assistant professor Ain, Uzn, Anf halq Wa Asnan (Eye, ENT and Density) appearing at S.No 11 of the engagement order;

AND WHEREAS, Principal, Government Unani Medical college cum Hospital Ganderbal Kashmir vide his communication No GUMC/PS/22-23/3083-86 dated 24.04.2023 informed that Dr. Shabir Ahmad Bhat did not join the Department of Ain, Uzn, Anf halq Wa Asnan (Eye, ENT and Density) against the post of Assistant professor within the stipulated time of 21 days;



NOW THEREFORE, in view of above, the engagement in favour of Dr. Shabir Ahmad S/o Farooq ahmad Bhat R/o Shadipora Sumbal against the post of Assistant professor Ain, Uzn, Anf halq Wa Asnan (Eye, ENT and Densitry) made vide Government order No 211-JK(HME) of 2023 dated 10.03.2023 is hereby cancelled with immediate effect.
