**Subject: Un-authorized absence of Dr. Abid Rasool, Medical Officer – joining thereof.**

**Government Order No. 544 – JK (HME) of 2023**  
**Dated: 04.07.2023**

**WHEREAS,** Director Health Services Kashmir vide communication No. DHSK/Legal/Ang-633/E-7046483/504 dated 15.11.2022 has intimated that Dr. Abid Rasool was appointed as Medical Officer vide Government Order No. 333-HME of 2018 dated 29.05.2018 and joined in the Directorate of Health Services, Kashmir on 07.06.2018 and was posted at D.H Kulgam vide Government Order No. 453-HME of 2018 dated 08.08.2018; and


**WHEREAS,** while posted as DH Kulgam, Dr. Abid Rasool, Medical Officer was selected for Registrarship in Government Medical College, Anantnag and joined the same on the directions of the Hon'ble High Court passed vide order dated 29.03.2019 in SWP No. 714/2019 titled Dr. Abid Rasool Vs State of J&K and others, the operative part of which is reproduced as under:-

***"In the meanwhile, subject to objections, it is ordered that the Principal Government medical College, Anantnag shall permit the petitioner to join as Registrar in General Medicines notwithstanding the fact that there is no NOC from the Health Department. The petitioner also be entitled to all consequential benefits attached against the post of Registrar".***

**WHEREAS,** in the meantime, the doctor was also selected for DM in Endocrinology at SKIMS Soura and he joined the same without seeking prior approval/NOC from the Competent Authority; and

**WHEREAS,** after completion of the said course, SKIMS Soura vide No. SIMS/ACAD/524 of 2022 dated 01.09.2022, relieved the doctor on 01.09.2022 and the doctor submitted his joining report on 29.09.2022 in the Directorate of Health Services, Kashmir and requested for allowing him to join his duties; and

**WHEREAS,** Dr. Abid Rasool, Medical Officer has also submitted a representation on 09.05.2023 in the Administrative Department, stating therein that he has submitted joining report before the Director, Health Services, Kashmir on 29.09.2022 immediately after completing Super Specialty Programme in the Department of Endocrinologist from SKIMS Soura, Srinagar and requested to allow him to join in the Department and being a Specialist in Endocrinology to serve the patient suffering from diabetes; and





**WHEREAS,** the doctor has shown his willingness to serve the patients and his specialization in Endocrinology shall be beneficial for the patients care, therefore, the Department has taken a lenient view and decided to accept the joining report of Dr. Abid Rasool (MD Endocrinology), Medical Officer.

**NOW, THEREFORE,** sanction is hereby accorded:-

- a) to allow Dr. Abid Rasool (MD Endocrinology), Medical Officer to join notionally w.e.f. 29.09.2022 and monetarily with immediate effect, subject to following conditions:-
  - i. He was not involved in any subversive activities as well as was not employed in any other Government/ private sector during the said period, for which an affidavit duly authenticated by the 1<sup>st</sup> Class Judicial Magistrate be obtained by the Directorate of Health Services, Kashmir.
  - ii. The concerned doctor is warned not to leave his place of posting for any occasion whatsoever in future, without proper permission from the competent authority, failing which, disciplinary action as warranted under rules, shall be initiated against him without any further notice.
- b) that the intervening period of his absence/undergoing DM in Endocrinology shall be decided by the Departmental Designated Committee, separately.


