2. Advance drawl of ₹ 17.001 lakhs (Rupees Seventeen Lakhs and One Hundred only) as detailed above, by Director, Sher-i-Kashmir Institute of Medical Sciences, Soura Srinagar for crediting the funds into the Single Nodal Agency (SNA) Account of the Scheme for its utilization on the approved components of scheme during the current financial year 2023-24 as per the revised procedure of CSS funds notified by Ministry of Finance, GoI, read with other SOPs/guidelines of the Finance Department.

The release of funds shall, however, be subject to the following conditions:

- a. The expenditure shall be made strictly, according to the classification under which funds have been authorized by the Finance Department.
- b. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
- c. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
- d. Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
- e. Director, Sher-i-Kashmir Institute of Medical Sciences, Soura Srinagar shall send status report about the scheme in terms of physical and financial progress made during the current financial year.

- f. Director, Sher-i-Kashmir Institute of Medical Sciences, Soura Srinagar shall send Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2024 to Govt. of India under intimation to this department.
- g. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.
- h. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BEAMS portal and accordingly release the funds to the concerned.
- i. The expenditure shall be incurred strictly as per the guidelines of the scheme and the conditions laid down in the sanction letter of the concerned ministry of Government of India.
- j. Red accounts of the advance drawl shall be furnished to the concerned quarters including A. G.'s office well in time.
- k. The funds shall not be available for re-appropriation/ diversion at any level.
- l. The funds shall be debited as per the following account classification:


