As recommended by J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Dr. Suby Singh** D/O Sh. Jasbir Singh R/O H. No 7A, Civil Line Sector D Ext. Sainik Colony, Jammu under OM Category as Lecturer in the Department of Pathology in State Cancer Institute (SCI), Super Specialty Hospital, Government Medical College, Jammu, in Pay Level-9 (52700-166700), subject to following terms and conditions:

- 1. The above candidate shall report to Principal, Government Medical College, Jammu. In case of failure of the appointee to join within a period of twenty-one (21) days from the date of issuance of this appointment order, she shall forego her appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.
- 2. The appointee shall be allowed to join only on production of following documents/certificates in original:
  - a. Date of Birth Certificate.
  - b. Qualification Certificates.
  - c. Domicile Certificate
  - d. Health Certificate from the Standing Medical Board.
  - e. Any other documents as required under rules.
- **3.** The appointment of the above candidate as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory reports in this regard are received in her favour.

- **4.** The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- 5. The appointee shall be on probation for a period of two (02) years.
- **6.** The seniority/promotion prospects of the appointee shall be maintained in the Department of Pathology, Government Medical College, Jammu.
- **7.** The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
- 8. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
