

Sanction is hereby accorded to the release of funds amounting to **Rs. 45,22,568/- (Rupees forty five lakhs twenty two thousand five hundred sixty eight only)** in favour of Director Finance, Health and Medical Education Department, out of the budget available under classification 2211-00-001-0099-2509-Ayushman Bharat (AB-PMJAY), Detailed Head 028-Grant-in-Aid and its advance drawl for further placement of these funds at the disposal of Chief Executive Officer, SHA AB-PMJAY, J&K (Bank Account No. 0110010230000014, J&K Bank, Civil Secretariat) to meet the Administrative Expenses of State Health Agency in accordance with the guidelines notified by National Health Authority (NHA).

The funds shall be utilized subject to the following conditions:-

1. The Chief Executive Officer, Ayushman Bharat (PMJAY), J&K shall vouchsafe the availability of funds under Sub Head 2509- Ayushman Bharat (AB-PMJAY).
2. The expenditure shall be booked on admissible items as mentioned in the guidelines of NHA and after fulfilling all requisite formalities as per rules/norms.
3. The funds shall be utilized specifically for the purpose for which these have been authorized. No diversion of funds shall be permissible under any circumstances.
4. The funds shall not be parked in the Bank Account unnecessarily.



5. Red Account/ UCs of the advance shall be furnished to the concerned quarters and the Accountant General, J&K within a stipulated time.
