As recommended by the J&K Public Service Commission, sanction is, hereby, accorded to the temporary appointment of **Dr. Rayees UI Hamid Wani** S/O Ab Hamid Wani R/O 111 Nehama Kakapora, under RBA Category, as Assistant Professor in the discipline of General Medicine in Government Medical College, Handwara, in the Pay Level-11 (67700-208700), subject to following terms and conditions:

- 1. The above candidate shall report to Principal, Government Medical College, Handwara. In case of failure of the appointee to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
- 2. The appointee shall be allowed to join only on production of following documents/certificates in original:
 - a. Date of Birth Certificate.
 - b. Qualification Certificates.
 - c. Domicile Certificate.
 - d. Reserved Category Certificate.
 - e. Health Certificate from the Standing Medical Board.
 - f. Any other documents as required under rules.

- 3. The appointment of the above candidate as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates/ Reserved Category Certificate from the concerned issuing authorities. The salary shall not be drawn and disbursed to him unless satisfactory reports in this respect are received in his favour.
- 4. The appointee shall be on probation for a period of two years.
- 5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- 6. The inter-se seniority of the candidate shall be determined in accordance with the merit assigned by J&K Public Service Commission.
- 7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
- 8. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
