In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Zia ul Islam, Medical Officer, SDH Kupwara for undergoing Post MBBS DNB course in General Medicine at SDH Kupwara for a period of one (01) year w.e.f. 16.11.2022 (out of three years) in the first instance.

However, this shall be subject to the following conditions that:-

 The Doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;

ii. The stipend, scholarship etc., if any, received during study leave is adjusted in his leave salary;

iii. the doctor shall execute a bond in form 6 before the Director, Health Services, Kashmir, as required under the J&K Civil Services (Leave) Rules, 1979;

iv. The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department before seeking extension in study leave; and

v. The doctor shall comply with all other conditions as laid down in study leave rules as amended from time to time.
