Advance drawl of 16475.00 Lakhs (Rupees One Hundred Sixty Four Crore & Seventy Five Lakhs) only as detailed above, by Mission Director, National Health Mission, J&K for crediting the funds into the Single Nodal Account (SNA) of NHM Scheme for its utilization during the current financial year 2022-23.
