WHEREAS, as per recommendation of the J&K Public Service Commission, the Health & Medical Education Department vide various Government Orders viz. Government Order No. 150-JK(HME) of 2023 dated 16.02.2023, Government Order No. 218-JK(HME) of 2023 dated 10.03.2023, Government Order No. 241-JK(HME) of 2023 dated 24.03.2023, Government Order No. 401-JK(HME) of 2023 dated 12.05.2023 & Government Order No. 450-JK(HME) of 2023 dated 30.05.2023 accorded sanction to the temporary appointment of 67 candidates (in respect of whom verification reports were received from J&K Criminal Investigation Department) as Medical Officers in J&K Health & Family Welfare (Gazetted) Service in the pay scale, Level-9 (Rs. 52700-166700), alonwith their postings subject to the fulfillment of various conditions which include the following:-

i. The appointee(s) shall submit their joining reports physically to their concerned Drawing and Disbursing Officers (DDOS) within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

ii. All the concerned Drawing & Disbursing Officer of Health & Family Welfare Department shall submit categoric report/details of appointees who fail to join physically within the stipulated time period immediately after expiry of 21 days to the Administrative Department by the concerned Directorates, besides, attendance alongwith documentary evidence in respect of the appointees, who joined physically, shall be submitted at the end of every month to the Administrative Department by the concerned Directorates and in case any discrepancy of facts is brought to the notice of Administrative Department, action as warranted under rules, shall be taken against such DDO(s);

AND WHEREAS, vide this department's letter dated 20.06.2023, the Director, Health Services, Jammu/Kashmir were requested to furnish the details of all the appointees who have failed to join physically before the concerned DDO's within the period of 21 days as prescribed in their appointment orders or are absconding from their place of postings after submission of their joining report;

AND WHEREAS, the Director, Health Services, Jammu/Kashmir vide their communication No. DHS/ES-3/1849 dated 28.07.2023 and No. Est-3/1-133/3691 dated 14.08.2023 respectively furnished the information/particulars of 16 Medical Officers (appointees) (09 from Jammu Province & 07 from Kashmir Province) who have failed to join at their respective place of postings up to the last day of their joining as per time line prescribed in their appointment orders. In addition, it has reported that 01 Medical Officer from Jammu Division has also absconded his duties immediately after submitting his joining report.

Now, therefore, it is hereby ordered that:-

i. the appointments in respect of following 16 Medical Officers vide Government Order's No. 150-JK(HME) of 2023 dated 16.02.2023, No. 218-JK(HME) of 2023 dated 10.03.2023 & No. 401-JK(HME) of 2023 dated 12.05.2023 shall be deemed to have been cancelled abinitio as these Medical officers have failed to join within stipulated time :-
