In continuation of Government Order No. 699-JK(HME) of 2023 dated 30.08.2023 and on the recommendations of J&K Public Service Commission, sanction is, hereby, accorded to the temporary appointment of **Dr. Naseer Yousuf Mir** S/O Mohammad Yousuf Mir R/O Maldera A/P Heffkuri Chitragam, under RBA Category, as Assistant Professor in the discipline of Paediatrics in Government Medical College, Handwara, in the Pay Level-11 (67700-208700), **notionally w.e.f 30.08.2023**, subject to following terms and conditions:

1. The above candidate shall report to the Principal, Government Medical College, Handwara. In case of failure of the appointee to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointee shall be allowed to join only on production of following documents/certificates in original:-
 - a. Date of Birth Certificate.
 - b. Qualification Certificates.
 - c. Domicile Certificate.
 - d. Reserved Category Certificate.
 - e. Health Certificate from the Standing Medical Board.
 - f. Any other documents as required under rules.

3. The appointment of the above candidate as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates/ Reserved Category Certificate from the concerned issuing authorities. The salary shall not be drawn and disbursed to him unless satisfactory reports in this respect are received in his favour.
4. The appointee shall be on probation for a period of two years.
5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
6. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
7. The inter-se seniority of the candidate shall be determined in accordance with the merit assigned by J&K Public Service Commission.
8. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
