The appointment of the above candidates shall be subject to following terms and conditions:

- 1. The above candidates shall report to Principal, Government Medical College, Udhampur. In case of failure of the appointees to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.
- 2. The appointees shall be allowed to join only on production of following documents/certificates in original:

- a. Date of Birth Certificate.
- b. Qualification Certificates.
- c. Domicile Certificate.
- d. Reserved Category Certificate (wherever applicable).
- e. Health Certificate from the Standing Medical Board.
- f. Any other documents as required under rules.
- 3. The appointment of the above candidates as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates/ Reserved category certificate from the concerned issuing authorities. The salary shall not be drawn and disbursed to them unless satisfactory reports in this respect are received in their favour.
- 4. The appointees shall be on probation for a period of two years.
- 5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- 6. The inter-se seniority of the candidates shall be determined in accordance with the merit assigned by the J&K Public Service Commission.
- 7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
- 8. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
