Sanction is hereby, accorded to the Administrative Approval for the Balance work of the project viz; "Construction of Sub-District Hospital at Damhal Hanjipora Kulgam" for an amount of ₹ 588.00 lakhs (Rupees Five Crore Eighty Eight Lakhs) only.

The Accord of Administrative Approval is, however, subject to the following stipulations:

- 1. that the balance works of the project are executed by JK Police Housing Corporation, strictly as per the details enclosed at **Annexure "A**" and item-wise reflections in original DPR duly vetted by Development Commissioner Works after adhering all codal formalities as contained financial rules in letter & spirit;
- 2. that the proposals shall be strictly devised and designed as per latest relevant I.S codes and specifications of MoRTH/ PWD/ CPWD and same is authenticated and proof checked by the competent authority (NIT/DIQC), before taking up execution in hand;
- 3. that the Electrical/Mechanical and Electronic Components are authenticated and technically vetted by the competent authorities of relevant field;
- 4. that the standard specifications are followed as per CPWD, NBC and I.S standards;
- 5. that the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE for the type of structures, proposed in the DPR are followed and adopted for the execution of the works;
- 6. that the rates for the items, not covered in JK SSR or any other relevant Schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures;
- 7. that the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures;

- 8. that the working of BOQs, based on approved design details/requirements, are framed as per J&K PWD Schedule of Rates for e- tendering purpose of the project;
- 9. that e-tendering mode is followed for fixation of the award of contract for execution of the project. Fragmentation of project, while tendering, is not allowed;
- 10. that the Technical Vetting is exclusively for the purpose of Accord of Administrative Approval and shall not be construed as any rate approval to the projects or any approval for inclusion in the plan;
- 11. that the balance works for completion of new building of Sub-District Hospital, framed on JK SSR 2020 involves no items for foundation work/frame/slabs for the structure as per DPR of the project;
- 12. that the timeline is strictly adhered to. No cost escalation/time over-run shall be admissible under any circumstances, whatsoever.
- 13. that NoC from all Regulatory Authorities are sought before the commencement of the work on the project;
- 14. that encumbrance free land is available for execution of the instant work on the project;
- 15. that the necessary load bearing capacity test of soil shall be undertaken at site, before taking execution of the project in hand;
- 16. that while designing, adequate provisions in design need to be incorporated for making the structures resistant to earthquakes to avoid any loss of property/ life.
