**WHEREAS,** Principal, Government Medical College, Doda vide letter dated 02.11.2023 has requested this Department for acceptance

**WHEREAS**, Article-201 of J&K Civil Service Regulations provides as under:

*"Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government service, provided the consent of the former departmental superior is obtained to accepting, such employment".*

**NOW, THEREFORE**, in terms of Article-201 of J&K Civil Service Regulations (Vol-1), sanction is, hereby, accorded to the acceptance of technical resignation of Dr. Shruti Sharma, Associate Professor (Anaesthesiology) in Government Medical College, Dodaw.e.f. 14.11.2023 on her own request, and her lien in J&K Medical Education (Gazetted) Service shall be deemed to have been terminated forthwith.
