AND WHEREAS, vide No. ES-3/5597/6589 dated 06.03.2023, Director, Health Services, Jammu has certified that Dr. Asha Manhas, Consultant Gynecologist remained present in the Directorate of Health Services, Jammu w.e.f. 21.06.2010 to 17.07.2010, in connection with awaiting orders of adjustment;

AND WHEREAS, the case for settlement of period w.e.f. 21.06.2010 to 17.07.2010 in favour of doctor was placed before the Departmental Designated Committee in its meeting held on 03.08.2023, which deliberated upon the case and recommended as under:-
