In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Sajad Ahmad Ahanger, Medical Officer, CHC Zainapora, Shopian for undergoing Post MBBS DNB (General Medicine) at JLNM, Hospital Rainawari, Srinagar for a period of one year (out of three years) w.e.f. 20.10.2023 in the first instance, subject to the following conditions:-

- i. He shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- ii. The stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his leave salary;
- iii. The doctor shall execute a bond in Form-6 before the Director, Health Services, Kashmir, as required under the J&K Civil Services (Leave) Rules, 1979;
- iv. The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department prior to seeking extension in study leave; and
- v. The doctor shall comply with all other conditions as laid down in study leave rules as amended from time to time.
